Introduction

By purchasing a license to the Fonts, Vivian Dehning grants You a non-exclusive, non-transferable license to access and use the Fonts as set out in the terms of this Agreement. No ownership rights are granted as a part of this Agreement herein.

You may not modify, adapt, translate, rename, reverse engineer, decompile, disassemble, alter or otherwise copy the Fonts, except as expressly provided herein.

Storing on publicly available servers, redistributing and selling of the Fonts or the data contained within the Font files is legally prohibited.

You may acquire the license to the Fonts on behalf of Your end user client. However, You must ensure that the end user client accepts and is bound by the terms of this Agreement without any alterations to its terms. You may not charge Your end user client any additional payment for the use of the Fonts and You may not use the same Fonts Yourself without an additional license.

The Basic License

The Basic License allows You to install and use the Fonts within Your Organization across most mediums including print, logos, web, app, social, videos and film. When purchasing a Font for Your client, each client needs a respective license. Delivered formats: otf, woff, woff2

License grant

You purchase a perpetual, worldwide, one-off license to use the Fonts within Your Organization. You may install the Fonts on any number of devices within Your Organization. Your Organization is the company You are the owner or employee of or the organization the company is part of, including all places of business. Your Organization shall not include clients or other third parties, including self-employed parties who are working for You but not at one of Your places of business. Providing the Fonts to any third parties is prohibited. Notwithstanding the aforesaid You may provide a copy of the Fonts to a repress bureau or printer as part of a file release if necessary.

Desktop

You may use the Fonts in any printed or digital materials including publications, static and motion images, packaging, apparel, titles and/or credits solely related to Your Organization. You may use the Fonts in assets for Your Organization's social media channels such as Instagram or TikTok.

Web

When using the Fonts for web development on websites, all Fonts have to be stored using an online storage to serve websites for which You or Your Organization have sole administrative access to (aside from the owner of the server). For each purchased license You are allowed to use the Fonts only on domains under Your and/or Your Organization's control. You are allowed to embed the Fonts into websites using the CSS @font-face method. Using third-party font hosting services is prohibited.

App

For app usage, You are allowed to use the Fonts to style live text in Applications created by Your Organization. The license granted herein is specific to You and the Applications under Your control. Your app may run on any software platform and operating system. You may not, without the express written consent of Vivian Dehning, transfer, loan, sell or assign the rights granted herein.

An Application is defined as a stand-alone application for one of the following operating system platforms, on versions that are less than 5 years old: Apple MacOS, Apple iOS, Android, Microsoft Windows. Other operating system platforms may also be covered under this Agreement if they support the font files as they are supplied by Vivian Dehning. However, She cannot provide any technical support for such other operating system platforms.

Video Broadcasting

When using the Fonts in video broadcasting such as television, cable & film, You are allowed to use the Fonts for one (1) title/production produced by Your Organization. You may use the Font in titles, credits or any other on-screen text for motion picture, TV series, animations, documentaries, advertising in TV, advertising in streaming services (e.g. Netflix/on-demand TV), online videos, movies or animations distributed on YouTube, Vimeo, TikTok etc.

To use the Font for multiple titles/productions, an extension of the Basic License is required, which is available upon request. For more information, please contact *mail@viviandehning.com*.

Embedding

You may embed the Fonts into PDF, PS and EPS files in a secured read/printonly mode provided that the document itself is not a commercial product. It is strictly forbidden to embed the Fonts in any way that would enable end users to access the Font files. You may never embed the Fonts directly into any physical devices or save the Fonts to a device and assign that device to any third party.

Pricing

The price of the license is determined by the total number of employees working in the end user's company (i.e. Your or Your client's company). It is not based on the amount of computers the Font files will be installed on or how many users will use the Fonts. If you purchase a Font for Your Organization, the price is based on the total number of people who work in Your Organization. When purchasing Fonts for Your client, the price of the license is determined by their company size, based on the total number of people who work in their organization.

If You use the Fonts for multiple clients, a respective license is required for each client. If Your or Your client's Organization grows, an upgrade to the

license is required. Please note the license terms for the usage of the Fonts in multiple on-screen productions as stated above.

As per a written request by Vivian Dehning, You will have to provide, without undue delay, records of the current size of Your Organization to prove that the license you purchased is applicable and in accordance with this Agreement. Vivian Dehning may run frequent checkups using publicly available database information.

Logo and custom usage

If the gross revenue of Your Organization exceeds EUR 5 million and You are using the Fonts in a logo or wordmark, You will need an extended and customized license. If you wish to use a customized or altered version based on the Fonts for any usage (e.g. titles, wordmarks) and for acquiring an extended and customized license, please contact *mail@viviandehning.com*.

The Fonts and the accompanying materials are protected by copyright and contain proprietary information and trade secrets of Vivian Dehning. Unauthorized copying of the Fonts even if modified, merged, or included with other software, or of the written materials, is strictly forbidden.

Technical standard and support

The licensed Fonts are provided "as is." Vivian Dehning aims to produce her fonts to meet the latest technical standard. If You demonstrate to Her that the Fonts do not essentially perform in accordance with the technical standard, She reserves the right to fix the shortcoming within 30 days from Your notice. If She fails to fix the shortcoming within 30 days, You may ask for a refund. After a refund, the respective license terminates with an immediate effect and any further use of the Fonts is strictly forbidden. Vivian Dehning will provide technical support for functionality of the Fonts but She cannot guarantee perfect functionality on every operating system platforms.

Warranties & liabilities

Vivian Dehning owns all rights in and to the Fonts and Your use of the Fonts in accordance with this Agreement will not infringe any third-party intellectual
